

Common program files have been already sent to 10 country teams (central banks, research institutes, ministries, productivity commissions), which will run them using their own firm-level data. ## Tokyo Workshop

January 11 – 12

Hosted by the Asian Development Bank Institute (ADBI) in Tokyo, the second PRN workshop was an occasion for members of the Network to discuss research related to the theme of “Productivity and Innovation”, as well plans for common data collection, based on firm-level information.

On the research front, papers took a large variety of perspectives on the theme, from the macro- international trade one (see for instance the keynote speech by Professor Romalis (Sydney University) on the impact of China exports on trade and prices in the US to the more macro-business cycle analysis, such as in the work by Hirata and World Bank staff looking at global productivity cycles. On the data front, we were presented six different firm level-based data by the corresponding country teams (Japan, Vietnam, India, New Zealand, Malaysia, and Australia). The presentations showed the diversity of the datasets in terms of coverage, but also - fully - the potential we have for developing a minimum common denominator of productivity-related indicators – based on common codes - which can be compared across the Asia-Pacific region. All the above teams – in addition to teams for Korea, China, Indonesia, Thailand – are currently running the common codes and will be ready in a couple of months to share the first aggregated results.
